## **INFORMATION CLAUSE**

Pursuant to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (further: GDPR), we would like to inform you that:

- *The Administrator of your data is IKS Foundation (Fundacja IKS) with its registered office in Busko-Zdroj, NIP: 959 195 85 72, REGON: 260788305;*
- *You can contact the Administrator via post at Lompy 14/500; 40-040 Katowice, Poland or via e-mail address [festiwal@kinolub.pl](mailto:festiwal@kinolub.pl);*
- *Your personal data will be processed in accordance with Article 6 (1) (a, b, c, d, e, f) and/or Article 9 (1) (a, b, c, d, h, i, j) of GDPR, in each case for the purpose stated in a detailed information clause, which can include in particular: the reservation of participation or the participation itself in film screenings, workshops, events or accompanying programs organized as part of the International Film Festival For Children and Youth KINOLUB; the submittal of films for festival selection and the later participation in competition screenings; or the sending of information regarding the Foundation's film and educational initiatives to interested parties;*
- *The Foundation declares that there might be recipients of personal information which will be appointed by the Foundation in each case;*
- *Your personal data will be stored for a period of 36 months;*
- *At any moment you have the right to demand from the Administrator: the access to your personal data, the correction of your personal data, the removal of your personal data, the limitation to the processing of your personal data, as well as the right to object to the processing of your personal data or to transfer them to another organization, and the right to withdraw your consent at any time without impacting the legality of the prior data processing;*
- *You have the right to lodge a complaint with the President of the Office of Personal Data Protection if Your data might have been processed in violation with the GDPR;*
- *The sending of your personal data is voluntary, however failing to submit data requested by the Administrator might result with losing the ability to make a reservation of participation in film*

*screenings, workshops, events or accompanying programs organized as part of the International Film Festival for Children and Youth KINOLUB*

- *In accordance with applicable law the personal data can be transferred by the Administrator to a third party that will process them at the Administrator's request, for example: festival location administrators, contractors, and entities entitled to the data access on the basis of applicable law, for instance courts of law or law enforcement authorities – only in case that these entities demands would be based on applicable regulations.*

*Your personal data will not be transferred to a third country or an international organization with the exception of law enforcement agency or courts of law based in third countries, in case of these entities such demands should be based on applicable regulations.*
